# STRATEGIC PLAN

## INTRODUCTION

- The NTRA was formed in 1983 with affiliate clubs the Darwin Rifle Club Inc. and the Central Australian Rifle Club Inc.
- Membership offers an active and safe environment for participation in target shooting at all levels of competition – social, state, national and international.
- Target shooting is an equal opportunity sport.

## MISSION STATEMENT

- To promote and develop the sport of target shooting in the Northern Territory in a safe and secure environment.

## BUSINESS STRUCTURE

- The Northern Territory Rifle Association is an incorporated association in accordance with the Northern Territory Associations Act.

## GOALS AND OBJECTIVES

The goals and objectives of the NTRA are to

- Be recognised by Governments and other associated clubs as a peak association within the shooting fraternity
- Market and promote the sport of target shooting to the wider community to ensure it is regarded as a responsible, safe and respected sport
- To promote membership to the affiliated clubs and encourage members to participate in Club, Territory, National and International competition
- Manage the association in a professional manner within the Constitution of the NTRA

## STRATEGIES

The NTRA strategies are focused on four key issues

1. Good Management
2. Membership
3. Member Services
4. Effective Representation

# TASKS

## 1. Good Management,

The NTRA will be a professionally run organization by;-

- Ensuring the Northern Territory Rifle Association is a legally incorporated association in accordance with the Northern Territory Associations Act.
- Conducting the Annual General Meetings in accordance with the NTRA Constitution
- Reviewing the Constitution from time to time to ensure the document remains relevant at all times
- Reviewing the policy documents of the Association from time to time
- Managing the Council through the voluntary elected management team of five elected members for a two year term at an annual general meeting, plus a representative of each of the two affiliated clubs elected by the clubs.
  - The Council will comprise of the following with a councillor being able to hold more than one position,
    - President
    - Deputy President
    - Secretary/
    - Treasurer
    - Public Officer

## 2. Membership

Membership to affiliated clubs will be promoted to new and existing member through

- Introducing and providing for a selection of target shooting disciplines
- Recognise potential in members and assist in achieving individual goals
- Assistance to affiliated clubs to develop “ Introduction to Rifle Shooting” awareness sessions that
  - Promote healthy competition
  - Training in the use of firearm safety
  - Mentors new shooters to become safe and competent shooters
- Forming a Team Selection Committee to manage the NT Team selection, comprising the Team Manager and Captain
- Developing involvement and participation in the North Australian Women’s (NTRA & NQRA) and in junior teams where possible

### **3. Member Services**

The NTRA will provide:

- Affiliation to the National Rifle Association of Australia and its goods and services as supplied from time to time
- Equal competition in gender and age
- Access and involvement in Territory and national competitions

### **4. Effective representation**

The NTRA will ensure the NTRA is represented by

- Participating in the NRAA either formally through the Board or by providing input into their decision making through relevant communications
- Representing members on appropriate committees and advisory boards in the Northern Territory
- Encouraging members to participate in affiliated clubs and other representative shooting bodies
